As per usual Milton gave me great support during the past 12 months.

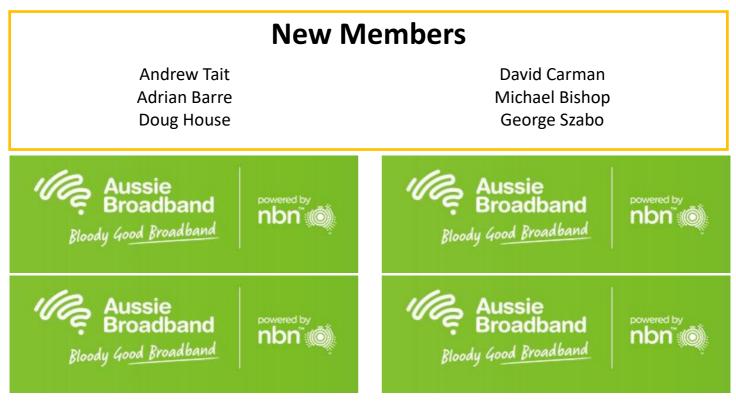
Assistant Secretary Ian Phillips did a great job on the membership. and controlling the shed mobile phone.
